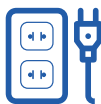
Asunción, Capital of the Republic of Paraguay

## CLIMATE

In Paraguay, the average temperature for November is estimated to be 30°C; minimum 20°C; maximum 36°C.

## ELECTRICITY

Paraguay operates with a supply voltage of 220V and 50Hz. In Paraguay, type C power outlets (plugs) are used.



## DRESS CODE

The general dress code of the event is semi formal or smart casual, we recommend comfortable shoes, light and cool clothing, a sweater or jacket for any change in temperature.

For the tours, we recommend light clothing and comfortable shoes to make the most of the tour.

## OTHER CONSIDERATIONS

The use of repellents outdoors is recommended to protect against insect bites. Paraguay issued a decree prohibiting the consumption of cigarettes or the use of vapes in closed and crowded public spaces, eliminating the smoking sections that existed in those places.

## DOLLAR RESTRICTIONS

Stained, wrinkled, or stamped bills are not accepted. Banks and exchange houses reduce the value of the bill when it has minimal alterations or do not accept it at all. Additionally, USD 100 bills with serial numbers starting with CB, DE, and DB are not accepted.

**1 USD = 7,580 Gs** (reference - Free and fluctuating exchange rate) \*Check online near the date of the event.

## RESTRICTIONS

Stained, wrinkled or stamped bills are not accepted. Banks and exchange houses reduce the value of the bill when it has minimal alteration or they do not accept it at all.

On the other hand, USD 100 bills, series that begin with CB, DE and DB.

## VAT

The Value Added Tax is 10%, prices do not always include VAT, we recommend always verifying that they include it.

## VISAS FOR ENTRY INTO THE COUNTRY

The Ministry of Foreign Affairs will grant visas, in the diplomatic representations and consular offices consular offices abroad and at the Visa Arrival Office in Visa Office at the Silvio Pettrossi Airport, to citizens of the citizens of the United States of America,

Canada, Australia and New Zealand. MERCOSUR countries do not require visas to enter the country.

## VACUNAS OBLIGATORIAS PARA INGRESAR MIGRACIONES

### MANDATORY VACCINATIONS TO ENTER MIGRATIONS

#### SANITARY REQUIREMENTS FOR ENTRY AND EXIT OF PARAGUAY

The National Direction of Migration informs about the current sanitary requirements for entry into Paraguay, provided by the Ministry of Public Health and Social Welfare, according to its latest updates:

#### COVID-19

As of October 24, 2022, the protocol for entry into the country dated 06/02/22 is no longer in effect, therefore, the presentation of the COVID-19 vaccination card or the RT-PCR test is no longer required for entry into Paraguay.

#### YELLOW FEVER

The Executive Power, through the Ministry of Public Health and Social Welfare, issued Resolution S.G. N° 275 which establishes the obligation to present the international certificate of vaccination against yellow fever in physical or digital format, as a requirement to authorize the entry into the country of foreigners coming from risk areas. Likewise, this certificate will be required both for the departure of foreigners residing in the country and for nationals going to risk areas.

Travelers going to or coming from the following risk areas must be vaccinated against Yellow Fever at least 10 days prior to their trip.

#### WHO MUST PRESENT THE CERTIFICATE?

##### 1) Foreigners coming from risk areas in:

- Bolivia (Beni and Santa Cruz)
- Brazil (Pará, Tocantins, Minas Gerais, São Paulo, Paraná, Rio Grande do Sul, Amazonas)
- Colombia (Villagarzón, Orito and Valle del Guamuez, Putumayo)
- French Guyana (Massara de la Cité Lethen)
- Perú (Junín; Ucayali, Ayacucho San Martín and Madre de Dios) and;
- Countries of the African Region: Cameroon, Chad, Congo, Democratic Republic of Congo, Guinea, Niger, Nigeria and South Sudan.

**2) Paraguayans and resident aliens traveling** to risk areas and Paraguayans and resident aliens returning from risk areas.

#### EXCEPTIONS

- People with medical contraindications to receive the vaccine must justify their situation through A certificate issued by a medical professional or by the Health Authority of the country of origin.
- Children under 1 year old and over 59 years old.
- Passengers in transit with stopovers of up to 24 hours in risk areas.

## What to do if I do not have the certificate?

- Non-resident foreigners who do not have the certificate will not be allowed to enter the country.
- Non-resident foreigners who have the certificate, but do not comply with the 10 days of having been vaccinated, will not be allowed to enter the country.
- Paraguayans and resident foreigners who do not have the certificate will be subject to sanitary control for 6 days.
- Foreigners who can enter for special situations are those who come for:  
humanitarian reasons, commercial reasons, specialized technicians, crew, other situations that the country considers necessary. This will be managed through the Directorate of Surveillance and Border Control, sending all the data to the mail: [cspe.dgvs@mspbs.gov.py](mailto:cspe.dgvs@mspbs.gov.py) 72 hours in advance.

## ■ YELLOW FEVER

### Symptoms

- Yellow fever presents with fever, headache, yellow eyes and skin (jaundice).
- It also causes muscle aches, nausea, vomiting, and fatigue.

### Prevention

Vaccination is the main disease prevention measure. It is administered once in a lifetime and does not require a booster dose.

### Who should be vaccinated?

- Population from 1 to 59 years of age who have not yet received the vaccine.
- In the event of an epidemic, children 6 months of age living in areas at high risk of infection may be immunized.

### Contraindications to the vaccine

The vaccine against yellow fever is contraindicated for:

- Children under 6 months of age.
- Pregnant women.
- People with a history of allergy to any of the vaccine components such as egg, chicken protein or gelatin.
- For those with immune system disorders, including human immunodeficiency virus (HIV) infection.
- People with thymus disease, myasthenia gravis, Digeorge syndrome, malignant tumors, organ transplants and pathologies requiring treatment with immuno-suppressants.
